OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN.

- <u>Sponsor</u>. FoodMaxx Supermarkets, a California corporation ("<u>Sponsor</u>") is offering the *Great American Backyard Cookout* (the "<u>Sweepstakes</u>") as described in these Official Rules.
- 2. <u>No Purchase to Enter</u>. NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS Sweepstakes.
- 3. <u>Prize(s):</u> The Prize for this sweepstakes is a \$100 FoodMaxx Supermarkets Gift Card Sponsor reserves the right to substitute prizes of equal or greater value at any time. No substitution or transfer of prize permitted, except by Sponsor who reserves the right to substitute a prize of comparable or greater value. Eligible prize winners will receive gift cards that may be redeemed at FoodMaxx Supermarkets. All references to a Prize are defined in the preceding sentence and use of the singular and plural tense of the word Prize is not intended to supersede, amend or alter the terms set forth herein
- 4. <u>Eligibility</u>. The Sweepstakes is open only to legal residents of California and Nevada, U.S.A., who are at least the age of majority at time of entry, and meet the eligibility requirements detailed below. Employees, officers and directors and their immediate families (spouses, siblings, children, household members and the spouses and children of the foregoing) of Sponsor are not eligible. By entering the Sweepstakes, participants agree to accept and be bound by all terms of these Official Rules, and participants agree to and acknowledge the Terms of Use and Privacy Policy of the Sweepstakes Site. The Sweepstakes is subject to all applicable federal, state and local laws and regulations.  - a. <u>Entry Procedures</u>. You can enter the Sweepstakes by posting a photo of your backyard campsite to your public Instagram profile (Instagram.com is the "Sweepstakes Site"). You must tag @FoodMaxx and use the hashtags "#GreatAmericanBackyardCookout" and "#FoodMaxx" in the status message in your Instagram post to be considered a valid entry. You may enter no more than one (1) photo of your back yard cook out setup. Once you have uploaded and posted your photo to Instagram, you cannot alter the image. However, you can remove your photo at any time and thereby withdraw your participation in the Sweepstakes. Once your entry has been selected as a potential winner you will not be able to withdraw or rescind the license granted to Sponsor as set forth in Section 9 of this Official Rules.

- b. Sponsor does not assume any responsibility for lost, late, incomplete, stolen, misdirected, or ineligible entries (including digital image files that do not comply with Sponsor's size and format requirements); or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/website/use net accessibility or availability, traffic congestion, or unauthorized human intervention.
- c. By entering the Sweepstakes, including by submitting your photo, you represent and warrant to Sponsor that you own all rights and title in and to the photo, that the backyard campsite depicted in the photo is your backyard campsite, that the photo does not infringe upon the rights of any third party, including but not limited to the copyrights in and to the photo, and that you grant to Sponsor a license to use the photo and the submitted information about you and your backyard for any purpose by Sponsor and waive any and all claims regarding Sponsor's use of the photo and the images and likenesses contained therein, in perpetuity.
- d. Sponsor reserves the right to remove a submitted photo at any time for any reason, in its sole and absolute discretion.
- 5. Sweepstakes Period. Sponsor reserves the right to modify, cancel, terminate or suspend the Sweepstakes at any time in its sole discretion. The Sweepstakes will begin on June 24th, 2020 at 12:01 AM Pacific Standard Time and end on July 21st 2020 at 11:59 PM Pacific Standard Time. Photos may be submitted beginning on July 1, 2019 at 12:01 AM Pacific Standard Time and ending on June 24th, 2020 at 11:59 PM Pacific Standard Time and ending on June 24th, 2020 at 11:59 PM Pacific Standard Time. Sponsor's clock shall be the clock of record. At the conclusion of the sweepstakes period, all entries will be compiled and a winner will be randomly selected. Only one (1) photo may be submitted by each household, as determined by Sponsor in its sole discretion. All additional entries submitted by the same household will be void. Winners will be notified through an Instagram Direct Message and will have forty-eight (48) hours to respond to Sponsor. If a winner fails to respond within this time frame, Sponsor will remove entry from the list and randomly select a new winner. The decision of Sponsor is final. When a winner is announced, the winning photo will be posted on the Sponsor's social media accounts and may otherwise be disseminated as Sponsor so desires (including sales, trades, barter, giveaways and/or as prizes).

Misc. Entries received prior to the start date or after the end date of the Sweepstakes Period will be disqualified. All entries must be submitted in the name of or represent an individual person and a prize can only be awarded to the person whose name is on or correlates to the winning entry. All entries become the property of Sponsor and will not be acknowledged or returned. False or deceptive entries or acts, as determined by Sponsor, will render the participant ineligible. Sponsor may prohibit any participant or potential participant from participating in the Sweepstakes, if at the sole discretion of Sponsor, such person shows a disregard for these Official Rules, or acts (1) in an unsportsmanlike manner; (2) with an intent to annoy, abuse, threaten, or harass any other participant, Sponsor, or their agents or representatives; or (3) submits photos that are obscene, pornographic, inappropriate, or that violate a third party's intellectual property rights, privacy rights or rights of publicity, or (4) acts in any other disruptive manner.

Any questions or disputes will be judged by Sponsor in its sole and absolute discretion and such determination shall be final in all respects and without recourse.

IF NOT RESOLVED THROUGH DIRECT DISCUSSIONS, ANY DISPUTE OR CLAIM SHALL BE RESOLVED BY FINAL BINDING ARBITRATION WITH AN EXPERIENCED ARBITRATOR LICENSED TO PRACTICE LAW IN CALIFORNIA. VENUE FOR ANY PROCEEDINGS WILL BE IN STANISLAUS COUNTY, CALIFORNIA.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

- 6. License to Submitted Photo and Winner's Information and Image. By entering the Sweepstakes, participants grant Sponsor and its affiliates the right, unless prohibited by law, to use the submitted photograph of their backyards, their names, city and state of residence, without compensation or consideration of any type what so ever, for the purpose of running this Sweepstakes, promoting this Sweepstakes, and any and all purposes of Sponsor and its affiliates, and participants grant all such rights to Sponsor for the purposes of advertising and publicizing the goods and services of Sponsor and all matters related to this Sweepstakes in any manner or medium, throughout the world in perpetuity without any royalty or financial compensation. By accepting a prize offered herein, the winner agrees to the use by Sponsor and its affiliates, for any and all purposes, of the submitted photograph(s), winner's name, city and state of residence, biographical information, voice, portrait, quotes, comments, image, pictures and likeness (collectively, "Winner's Information and Image"), without further compensation or consideration, in any and all media now known or hereafter developed throughout the world in perpetuity, unless prohibited by law and releases Sponsor from any and all claims and demands arising out of the use of the Winner's Information and Image. This consent and release includes, but is not limited to, any and all claims and demands for libel and unauthorized commercial uses under California Civil Code Section 3344.
- 7. Prize Form and Affidavit/Liability/Publicity Release. - 12. <u>Governing Law; Venue</u>.
